**Application u/s 439 Cr.P.C of applicant-accused Rahul @
Kalu for grant of regular bail.**

Detailed arguments heard. Records perused
carefully.

The main objection to the bail application of the
applicant-accused is that he remained PO from 20.07.2017 till
26.02.2020. Admittedly, the role of applicant-accused is same as
that of co-accused Vishal @ Chinku who is on regular bail in the
present case. It has been pointed out that applicant-accused was
on interim bail w.e.f. 27.11.2021 till 26.01.2022.

Ld. Counsel for the applicant-accused has submitted
that after expiry of interim bail, he had surrendered before the
Jail Superintendent concerned and never misused the bail. Ld.
Counsel for the applicant-accused has further submitted that no
other bail application of the applicant-accused is pending before
any other Court including the Hon'ble High Court of Delhi.

In these facts and circumstances, keeping in view the role of the applicant-accused and the fact that trial would take sometime to conclude, **the applicant-accused Rahul @ Kalu is admitted to regular bail on furnishing of personal bond-cum-surety bond in sum of Rs 50,000/- each with two (02) sureties in the like amount subject to following conditions :**

- (i) **the applicant-accused shall not be found in the vicinity of the family members of the deceased at any point of time;**
- (ii) **he shall not contact any of the PWs directly or indirectly in any manner and shall not tamper with the evidence;**
- (iii) **he shall not leave the country without permission of the Court;**
- (iv) **he shall keep his mobile phone on at all times;**
- (v) **he shall drop a PIN on the google map to ensure that his location is available to the Investigating Officer;**
- (vi) **he shall commit no offence whatsoever;**
- (vii) **he shall remain present in person or through his Counsel in the present case on every date of hearing fixed and/or as and when so directed by the Court;**
- (viii) **he shall not seek frequent exemptions or adjournments.**

The application of applicant-accused Rahul @



Kalu for grant of regular bail, accordingly, stands disposed of.
